

Contractor Application Form: Introduction

Most of our work is carried out on domestic properties managed by local government social housing agencies. The Building Safety Regulator is enforcing more stringent expectations that our clients must demonstrate they only engage refurbishment contractors who are competent and qualified to work on their properties. Consequently, our clients are imposing upon us the same requirements to:

- demonstrate we are competent to do the work we are engaged to complete;
- meet all relevant Fire Safety and Building Standards; and
- comply with all their H&S rules when our operatives are on their sites.

If we engage your firm, you must demonstrate the same level of competence and commitment to building safety and H&S as we operate onsite. This form aims to collect the information we need from you to evaluate your competency and commitment to safe working practices.

You must satisfactorily complete every section on this firm and supply the requested supporting evidence before we can consider engaging your firm to work with us.

As a sole trader in a *contract for service*, you can:

- Only bill for materials and personal labour you provide.
- You have no rights of worker substitution.
- You cannot engage another person to help you fulfil your work.
- You must carry a minimum of £5m Public Liability insurance, and provide proof your insurance policy has an *Indemnity to Principals* clause. Many of our clients require £10m cover. We can only engage you for these clients if you match the £10m cover.
- Unless you can demonstrate alternative H&S training carried out by an external agency to meet our requirements, you must attend an induction morning at our Poole Unit and subsequently complete a mandatory set of online H&S training courses (approximately 8 hours) before starting to work on our site. This is not negotiable.

As we will mostly be engaging your services for CIS-qualifying work, you should assume you will be billing us under the domestic reverse VAT rules where you charge no VAT on your services, and Marisco accounts for the VAT to the HMRC.

We will confirm the appropriate VAT charging system on a project-by-project basis.

3. Your trade, professional, and employer's liability insurance policies

We are not alone in experiencing an ever-increasing demand from our company's insurance underwriters to meet their competency and compliance expectations.

Marisco now undergoes an annual insurance underwriter's audit to ensure we meet their compliance standards on the engagement of competent contractors. The information we ask you to provide us in this questionnaire fulfils our obligations to our insurance underwriters.

We must also consider the implications of the amendments to the *Defective Premises Act* introduced by the *Building Safety Act 2022*, which has extended the period in which a claimant can claim for the costs of rectifying relevant defects from 6 years to 30 years.

This is in addition to the *Defects Liability Period* to be agreed on in our service level agreement, which you must complete as part of this engagement application.

4. Public Liability Insurance Cover

We require all our contractors to carry a minimum of £5m public liability insurance cover. Many of our clients only accept operatives on site if they carry a minimum £10m public liability insurance. Having the lower £5m level will restrict what sites we can invite you to work on.

Indemnity to Principal Clause

Our insurance underwriters require us to ensure any contractor we engage holds an insurance policy that includes an *Indemnity to Principal* clause.

7. Control over the operatives you intend to put on our site.

Many of our clients, and our insurance underwriters restrict the kind of operatives our contractors can send onto our sites. They are limited to being either:

- Your directly employed employees who are paid under your PAYE scheme.
- Your individual workers who do not carry their own insurance cover and have been accepted by your insurance provider as labour-only workers.

It is a specific condition of engaging your firm that you cannot engage any other contractor to assist you in completing your work onsite without our written permission. Your nominated contractor must undergo the same contractor onboarding process we are carrying out for your firm.

To avoid any misunderstanding about how seriously we police the operatives we allow onsite, we ask you to confirm the following. If you answer "No" to any of the following questions, your application will not be taken further.

7.5 You confirm you have taken all reasonable steps to ensure your operatives are both **competent** and **qualified** to undertake the work we have engaged your firm to fulfil. You may be asked to provide evidence of your operatives' competency and qualifications before work commences.

7.7 You confirm your operatives understand they must read and sign our Site File paperwork. They contain our own site risk assessments and method statements your operatives must comply with. Your operatives must also be able to produce upon request your own risk assessments you have prepared for the work in hand. Any of your operatives who fail to sign our site file, including the sheet that records site arrival and departure, will be asked to leave the site immediately.

We cannot understate the need for contractors to comply with the level of H&S compliance we now exercise and enforce on our sites.

Any of your operatives who do not fully cooperate with any reasonable request from an authorised site manager or H&S inspector (Marisco or Client) to comply with the safe working policies and site rules, will be asked to leave site and not return. You will indemnify this firm against all costs that arise from that action.

8 Contractor's Health and Safety Compliance

All Marisco construction sites will have a *Site Safety File* that contains relevant risk assessment, method statements and other site rule documentation and guidance.

Every one of your operatives entering one of our sites for the first time, must read the Site Safety File and sign their agreement to work according to the rules laid out in the various safe working documentation contained therein. A Marsico staff member will be onsite to assist with the process.



As a contractor to Marisco, you must demonstrate your firm exercises a minimum level of H&S compliance and training within your organisation. Please confirm the following to evidence that commitment to H&S.
