- Product Assessment: Identify products that fall under the Construction Products Regulations and work
 with our supply chain to ensure we have received confirmation of conformity assessments for all
 applicable products.
- **UKCA Marking:** Ensure that the UKCA mark is affixed to all relevant products, packaging, or accompanying documentation that are received from suppliers.
- **Technical Documentation:** Ensure a Declaration of Performance (DoP) for each applicable product, detailing its performance characteristics and compliance is received from suppliers.
- Quality Management: Implement and regularly review quality control procedures to ensure ongoing
 compliance and conduct regular internal and external audits to verify product conformity and address
 non-compliance issues promptly.
- *Training and Communication:* Provide regular training for employees on the Construction Products Regulations and UKCA marking requirements and communicate compliance policies and updates clearly to all stakeholders, including employees, subcontractors, and suppliers.
- **Supplier Verification:** Verify that all suppliers and subcontractors provide UKCA marked products where applicable and maintain their own compliance processes and meet our company's quality standards.
- **Continuous Improvement:** Regularly review and update compliance policies and procedures to reflect changes in regulations and industry best practices and engage with industry bodies and participate in forums to stay informed about regulatory updates and compliance strategies.

5. Responsibilities

- **Compliance Manager:** Oversee the implementation and maintenance of this policy. Ensure all employees and stakeholders understand and adhere to compliance requirements.
- **Quality Control Team:** Conduct conformity assessments, manage technical documentation, and perform regular audits.
- HR and Training Team: Develop and deliver training programs on compliance requirements.
